#### **CONSIDERATIONS AND REQUESTS**

A. South Sound 911 Contract

The agreement reflects the organizational status change from an Interlocal agency to a public authority. Commissioner Stringfellow moved and Commissioner Eckroth seconded to approve the South Sound 911 Fire Communication Services Agreement effective January 1, 2020. **MOTION CARRIED**.

B. Bethel School District Interlocal Agreement

A similar agreement providing for emergency facilities use has been in place since 2011. Commissioner Eckroth moved and Commissioner Stringfellow seconded to approve the Interlocal Agreement with Bethel School District for emergency facilities use dated January 13, 2020. **MOTION CARRIED**.

# C. ERF Budget

FD Robacker explained the need for 2019 and 2020 ERF adjustments. Commissioner Coleman moved and Commissioner Stringfellow seconded to authorize a 2020 appropriation in the amount of \$219,837, transferring from the General Fund \$174,837 to Equipment Replacement Fund (ERF) Division 340 for Medic Unit up-fitting, and transferring \$45,000 to ERF Division 300 for a staff vehicle. **MOTION CARRIED**. Commissioner Eckroth moved and Commissioner Stringfellow seconded to authorize a 2019 Adjustment to General Fund and ERF that will increase cash in the ERF by \$350,000. **MOTION CARRIED**.

L726/P James introduced Shaun Cuthbert, the new L726 Secretary/Treasurer. James updated the Board on union activities.
