A. Fire Benefit Charge Appeal

Carlene Easterwood submitted a request to reduce the Fire Benefit Charge on her mobile home park (parcel no. 0420226009) from a commercial rate to residential rate.

Structures under the parcel are carports only, are of minimal value, and any fire response would be considered a residential response. Individual mobile homes on the property each pay a benefit charge. Commissioner Willis moved and Commissioner Eckroth seconded to approve reducing the 2020 fire benefit charge on parcel no. 0420226009 from a commercial rate of \$1,270.44 to a residential rate of \$319.40. **MOTION CARRIED.** 

B. Paramedic/Firefighter Hiring Notification

The document memorializes the hire date and seniority rank of the new employees based upon their total weighted score from their respective pre-employment hiring process. For this academy, the ranking was the Firefighter/Paramedic candidates first, followed by the Firefighter candidates.

C. 2020 Washington State Fair Service Agreement

Staff and Fair administration met to discuss the contract. Agreed amount is 2019 costs plus CPI. Commissioner Eckroth moved and Commissioner Willis seconded to approve the 2020 Fire Protection and Emergency Medical Services Contract with the Washington State Fair for \$197,224.74. **MOTION CARRIED.**
