A. Board Organization Discussion

Chair Homan reported that the Board wishes to maintain continuity in the preparation of Board meetings. The Chair opened the floor for discussion on establishing a formal process for Board Members to submit agenda items. A proposal was made for the Board to consider appointing Co-Chairs through the end of 2025. After brief discussion, it was agreed that Chief Morrow will schedule agenda review meetings, and all three Board Chairs may attend as their schedules permit.

B. Naming Convention Discussion

Chief Morrow asked for direction regarding two topics related to the merging Districts. Item 1.) Solicit a 3rd party consultant to lead a public naming process to be budgeted and completed in 2026. Item 2.) Use a joint logo to start emphasizing the combined District, and stop using individual logos, except where legally required. The Board provided concurrence on both items.

C. Strategic Plan Discussion

Chief Morrow noted that strategic alignment between the 3 merging agencies is needed before a combined Strategic Plan can be adopted in 2027. To support this effort, the Chief requested direction from the Board to compile a comprehensive list identifying operational elements necessary for organizational integration over the next six months. This list will include, but is not limited to, all station locations, apparatus assignments, and staffing models. The Board provided consensus to compile a comprehensive list.

SUMMARY:

The South Pierce Fire & Rescue Contract Extension was presented for First Reading on June 23rd. Attorney Eric Quinn has made the following changes as requested by South Pierce Fire & Rescue and as discussed with the District:

1. The original contract elements remain intact with modification to the term, representing the intent of the extension.
2. Payment terms have been modified to represent monthly payment starting July 1, 2025 in the amount of \$35,000 monthly.
3. District Secretary services have been added in the scope section. This change is due to the loss of South Pierce Fire & Rescue's District Secretary. After discussion with Director Roberts, Deputy Director Kim Kemp will provide the services requested.

The contract extension is now in front of the Joint Board for second reading.

FINANCIAL IMPACT: \$35,000 monthly revenue

INTERLOCAL AGREEMENT BETWEEN SOUTH PIERCE FIRE & RESCUE AND CENTRAL PIERCE FIRE & RESCUE FOR INTERIM FIRE ADMINISTRATION SERVICES

This interlocal agreement ("Agreement") is made and entered into by and between Central Pierce Fire and Rescue ("CPFR"), South Pierce Fire and Rescue ("SPFR"), both parties being Washington municipal corporations. CPFR and SPFR are referred to collectively in this Agreement as the "Parties" and each individually as a "Party."

RECITALS

WHEREAS, the Parties are authorized by RCW 52.12.021 and RCW 39.34.030 to enter into this Agreement; and

WHEREAS, SPFR's present Fire Chief is set to resign effective June 30, 2024; and

WHEREAS, CPFR and SPFR have explored the potential for an interlocal agreement by which CPFR would provide one (1) CPFR Deputy Chief to act as the SPFR Fire Chief of SPFR; and

WHEREAS, the Parties desire for CPFR to provide such interim executive, operational, and administrative services to SPFR on the terms and conditions provided in this Agreement; and

NOW, THEREFORE, in consideration of the mutual promises set forth below and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

TERMS

1. **Purpose.** The purpose of this Agreement is to establish a contractual arrangement under which CPFR shall provide Interim Fire Administration Services to SPFR, as more specifically defined in the Scope of Services, attached hereto as Exhibit A.
2. **Effective Date and Term.** This Agreement shall take effect on July 1, 2024 ("Effective Date") and shall remain in effect until June 30, 2026 ("Initial Term"), unless earlier terminated by either Party in accordance with Section 3 below. SPFR's Board Chair, or designee, and the CPFR Fire Chief shall meet annually to discuss the potential extension of this Agreement.
3. **Termination.** This Agreement may be terminated by either Party:
 - a. Without cause, upon 180 days' advance written notice from the terminating Party to the other Party; or

- b. For a material breach or other good cause, upon 15 days' advance written notice to the breaching Party, with an opportunity to cure during that period.

Upon termination of this Agreement, CPFR shall be relieved from any further obligation to provide services hereunder, and SPFR shall be liable only for payment attributable to the services satisfactorily rendered by CPFR prior to the effective date of termination.

This Agreement shall automatically renew for one-year periods (“Renewal Terms”) if neither party terminates this Agreement in accordance with this Section, but still being subject to this Section. For example:

Initial Term:

- July 1, 2024 – June 30, 2026

Key Deadline for Renewal:

- If no written notice of termination is given by January 1, 2026 (i.e., 180 days before June 30, 2026), the Agreement automatically renews.

But:

- On September 15, 2026, SPFR gives 180-day advance written notice of termination without cause.

Effect:

- The Agreement remains in effect for 180 more days, which ends on March 14, 2027.
- The Agreement terminates early, before the end of the Renewal Term (i.e., before June 30, 2027).
- The parties are still bound during that 180-day window, but service ends March 14, 2027, not June 30.

4. **Services.** CPFR shall provide the Interim Fire Administration Services generally outlined in Exhibit A ("Scope of Services") to SPFR. CPFR hereby assigns CPFR Deputy Chief **Zane Gibson** to be the SPFR Fire Chief. The CPFR Fire Chief, Dustin Morrow, will be SPFR’s primary point of contact for administration of this Agreement and shall assign SPFR executive staff necessary to support SPFR.

4.1 During the Initial Term or any Renewal Term, the SPFR Fire Chief shall be the sole CPFR employee performing services to SPFR under this Agreement, subject to Exhibit A hereto. The SPFR Fire Chief shall be under the direction and control of the CPFR Fire Chief,

although the SPFR Board of Fire Commissioners retains the right to voice concerns about the services provided by the SPFR Fire Chief.

4.2 The SPFR Fire Chief shall supervise executive and administrative staff in performing the duties necessary and shall exercise reasonable discretion in assigning or delegating work to other suitable CPFR personnel as appropriate to meet the needs of SPFR. The duties, qualifications, and expectations of the executive staff are further specified in the attached Exhibit A which is incorporated herein by reference.

5. **Compensation for Services.** With this Section not applying to compensation remitted prior to July 1, 2025, commencing July 1, 2025 SPFR shall pay CPFR \$35,000 per month (the "Fee"), which the Parties agree is the full and true value for Interim Fire Administration Services rendered under this Agreement. In the event this Agreement is extended pursuant to Section 2, the Fee will be increased at the beginning of any Renewal Term by the semi-annual (January to June) Seattle/Tacoma CPI-W of the year in which the notice of intent to extend is given, with the increase not to exceed 3% of the previous contract year's Fee. If said CPI-W is zero or negative, the Fee will remain unchanged for the Renewal Term. In the event of early termination in accordance with Section 3 herein, the Fee shall be pro-rated to reflect actual days of work performed by CPFR prior to termination, or any portion of the Lump Sum shall be refunded to reflect that the remaining days of the Term or any Renewal Term, with either scenario taking Section 3 into account (180 days' written notice of termination), with no compensation owed after the date of termination. By way of example only:

SPFR gives CPFR written notice of termination without cause on October 1, 2025. The termination becomes effective 180 days later, on March 30, 2026. CPFR is entitled to compensation for 9 full months of service (October through March), calculated at follows: $\$35,000 \times 6 = \$210,000$

5.2 CPFR shall perform the duties and responsibilities required to meet the terms of this Agreement and as generally outlined in Exhibit A ("Scope of Services").

5.3 CPFR shall issue a monthly invoice for the Fee on the last day of the month; payment shall be due from SPFR within 30 days of receipt.

5.4 The Board Chair and SPFR Fire Chief shall meet at least monthly to review performance of the Agreement. Any adjustments to the Fee set forth in this Section 5 shall be mutually agreed upon in a written amendment to this Agreement.

6. **Indemnification.** To the extent permitted by law, each Party shall defend, indemnify, and hold the other Party (including its officers, officials, employees, agents, consultants, and volunteers) harmless from any and all claims, liabilities, injuries, damages, losses, and expenses, including, but not limited to attorneys' and expert's fees and court costs, arising out of or in connection with the indemnifying Party's performance of its obligations under this Agreement,

except for injuries or damages resulting from the sole negligence or intentional acts of the Party requesting indemnification. If a court of competent jurisdiction determines that this Agreement is subject to RCW 4.24.115, then the indemnifying Party's duty to indemnify for injuries, losses, damages, or expenses arising from the concurrent negligence of both Parties (including their officers, officials, employees, agents, consultants, and volunteers), shall apply only to the extent of the indemnifying Party's own negligence.

EACH PARTY UNDERSTANDS THAT THE INDEMNIFICATION PROVIDED HEREIN CONSTITUTES A SPECIFIC AND EXPRESS WAIVER OF THE IMMUNITY GRANTED UNDER THE WASHINGTON STATE INDUSTRIAL INSURANCE ACT, TITLE 51 RCW, SOLELY FOR THE PURPOSES OF THIS INDEMNIFICATION. THE PARTIES ACKNOWLEDGE THAT THEY HAVE MUTUALLY NEGOTIATED THIS WAIVER. THE PARTIES' WAIVER OF IMMUNITY UNDER THE PROVISIONS OF THIS SECTION EXTENDS ONLY TO CLAIMS BETWEEN THE PARTIES, AND DOES NOT INCLUDE, OR EXTEND TO, ANY CLAIMS BY A PARTY'S EMPLOYEES DIRECTLY AGAINST THAT PARTY.

The provisions of this Section 6 shall survive the expiration or termination of this Agreement.

7. **CPFR Insurance.** CPFR shall procure and maintain without interruption during the term of this Agreement, insurance against claims for injuries to persons or damage to property which may arise from or in connection with the performance of the services hereunder by CPFR, including its agents, employees, and representatives. CPFR's maintenance of insurance as required by this Agreement shall not be construed to limit the liability of CPFR to the coverage provided by such insurance, or otherwise limit SPFR's recourse to any remedy available by law or in equity. At a minimum, CPFR shall obtain insurance of the types and coverage described below from insurers having a current AM Best rating of not less than A-VII.

7.1 Commercial General Liability insurance shall be at least as broad as ISO occurrence form CG 00 01 and shall cover liability arising from premises, operations, stop gap independent contractors, and personal injury and advertising injury. SPFR shall be named as an additional insured under CPFR's Commercial General Liability insurance policy with respect to the work performed for SPFR using an additional insured endorsement at least as broad as ISO CG 20 26. Coverage shall be maintained with limits no less than \$1,000,000 each occurrence, \$2,000,000 general aggregate.

7.2 Workers' Compensation coverage as required by the Industrial Insurance laws of the State of Washington.

7.3 CPFR's insurance policies shall contain or be endorsed to contain the following provisions, copies of which shall be furnished to SPFR before commencement of the services to be provided under this Agreement:

a. CPFR's insurance coverage shall be primary insurance as respects SPFR. Any insurance, self-insurance, or insurance pool coverage maintained by SPFR shall be excess of the CPFR's insurance and shall not contribute with it.

b. CPFR's insurance shall be endorsed to state that coverage shall not be cancelled by either party, except after thirty (30) days prior written notice has been given to SPFR.

7.5 If CPFR maintains higher insurance limits than the minimums shown above, SPFR shall be insured for the full available limits of Commercial General and Excess or Umbrella liability maintained by CPFR, irrespective of whether such limits maintained by CPFR are greater than those required by this Agreement or whether any certificate of insurance furnished to SPFR evidence limits of liability lower than those maintained by CPFR.

7.6 Failure on the part of CPFR to maintain insurance as required shall constitute a material breach of contract, upon which SPFR may, after giving five business days' notice to CPFR to correct the breach, immediately terminate the Agreement or, at its discretion, procure or renew such insurance and pay any and all premiums in connection therewith, with any sums so expended to be repaid to SPFR on demand, or at the sole discretion of SPFR, offset against funds due CPFR from SPFR under this Agreement.

8. **SPFR Insurance.** SPFR represents and warrants that it shall secure and maintain suitable insurance during the performance of this Agreement, with said insurance limits being set at or near those set forth above at Sections 7.1 and 7.2. In addition, SPFR shall maintain the following insurance:

Automobile Liability insurance covering all owned, non-owned, hired, and leased vehicles. Coverage shall be written on Insurance Services Office (ISO) form CA 00 01 or substitute form providing equivalent coverage. If necessary, the policy shall be endorsed to provide contractual liability coverage. Coverage shall be maintained with a minimum combined single limit for bodily injury and property damage of \$1,000,000 per accident

9. **Compliance with Laws.** The Parties, in performance of this Agreement, shall comply with all applicable local, state, and federal laws and ordinances, including standards for licensing, certification, and operation of facilities, programs, and accreditation, and licensing of individuals and any other standards or criteria as described in this Agreement to assure quality of services.

10. **Confidentiality of Information.** All confidential information shared by SPFR with CPFR in connection with the services performed under this Agreement shall be maintained in confidence

and will be safeguarded by CPFR to at least the same extent as CPFR safeguards like information relating to its own business. If such information is publicly available or is already in CPFR's possession or known to it or is rightfully obtained by CPFR from third parties, then CPFR shall bear no responsibility for its disclosure, inadvertent or otherwise.

11. **Email Communications and Public Records.** The SPFR Fire Chief shall be given a SPFR email account for conducting business related to SPFR. Communications between or among CPFR employees (including the SPFR Fire Chief) and SPFR employees concerning SPFR matters shall primarily be conducted using SPFR email addresses. CPFR public records personnel shall give at least 30 days' notice to SPFR's legal counsel before producing records in response to any public records requests seeking production of any records concerning SPFR or CPFR's contractual relationship with SPFR. This notice period shall include an opportunity for SPFR legal counsel to review and request redactions to responsive records (or seek a court injunction) before CPFR produces any such records to the requester. This provision shall not be construed as relieving CPFR of the prompt-response requirements set forth under RCW 42.56.520 or any recodification thereof. This obligation to provide notice survives the termination of this Agreement.

12. **Non-Discrimination in Employment and Services.** The Parties are equal opportunity employers, and shall not discriminate against any employee or applicant on the grounds of race, color, religion, sex, sexual orientation, national origin, creed, marital status, age, veteran status, or the presence of any disability; provided that the prohibition against discrimination in employment because of disability shall not apply if the particular disability prevents the particular worker involved from performing the occupational requirements of the job. The Parties shall not, on the grounds of race, color, sex, sexual orientation, religion, national origin, creed, marital status, age, veteran status, or the presence of any disability deny any individual any services or other benefits provided under this Agreement.

13. **Interim Chief Remains Employee of CPFR.** Nothing in this Agreement shall be interpreted as SPFR becoming the employer of the SPFR Fire Chief or other personnel—CPFR remains the employer of the SPFR Fire Chief. Neither Party shall assume any liability for the direct payment of any salary, wages, or other compensation of any type to any of the other Party's personnel performing services hereunder. No agent, employee, or other representative of either Party is intended to be, nor shall be deemed to be, an employee of the other Party for any reason.

14. **Assignment.** The Parties shall not assign this Agreement or any interest, obligation, or duty therein without the express written consent of the other Party, whose consent shall not be unreasonably withheld or delayed.

15. **Dispute Resolution, Jurisdiction, Venue, and Choice of Law.** If any judicial action is brought to resolve a dispute arising under or related to this Agreement, the exclusive venue shall be in Pierce County Superior Court, which the Parties agree has exclusive personal and subject-

matter jurisdiction for such action. In any such action, each Party shall bear its own costs and expenses, including attorney fees. The interpretation, construction, and enforcement of this Agreement shall be governed by the laws of the State of Washington, without reference to its choice-of-law rules. The Parties expressly waive their right to a jury. Neither Party may initiate any judicial action relating to this Agreement before having first sought to resolve the dispute informally by written demand and a 10-day period for discussions between the Board Chair and the CPFR Fire Chief. Nothing in this Agreement shall be construed as preventing or delaying either Party from seeking temporary or preliminary injunctive relief or other emergency judicial orders as necessary to avoid irreparable harm.

16. **Notices.** All notices, requests, demands, or other communications pursuant to this Agreement shall be in writing and shall be deemed effective if personally delivered or mailed, registered, or certified mail, return receipt requested, postage pre-paid, upon deposit in the United States mail, to the Parties at the following addresses:

The Parties agree that the addresses of all Parties to which notice shall be given may be changed at any time by written notice to the other Party.

17. **Independent Municipal Governments.** The Parties hereto are all independent municipal corporations. Except for the specific terms herein, nothing herein shall be construed to limit the discretion of the governing bodies of either Party. Nothing in this Agreement shall be construed to create a joint entity between the Parties. Any property to be held in connection with this Agreement shall be held as the separate property of the Party in whose name the property is or was acquired. No provision of this Agreement shall relieve either Party of its public agency obligations and/or responsibilities imposed by law. Neither Party intends, by virtue of this Agreement, to effect or authorize any delegation of its authority to establish or amend policies, enter into agreements, or take any other actions that are within its authority and discretion under law. This Agreement shall

be administered by the CPFR Fire Chief and no property shall be exchanged between the Parties pursuant to this Agreement, except as expressly set forth herein.

18. **No Benefit to Third Parties.** This Agreement is entered into for the benefit of the Parties and shall confer no benefits, direct or implied, on any third persons. Nothing herein shall be construed as creating an exception to the Public Duty Doctrine.

19. **Neutral Authorship.** Each of the provisions of this Agreement has been reviewed and negotiated directly between the Parties and represents the combined work product of the Parties hereto. No presumption or other rules of construction or interpretation which favor one Party over the Party shall apply to the construction or interpretation of any of the provisions of this Agreement.

20. **Non-waiver of Breach.** The failure of the either Party to insist upon strict performance of any of the covenants and agreements contained herein, or to exercise any option herein conferred in one or more instances, shall not be construed to be a waiver or relinquishment of said covenants, agreements, or options, all of which shall be and remain in full force and effect.

21. **Counterparts.** This Agreement may be executed in any number of counterparts, each of shall be deemed to be an original instrument, and all such counterparts together shall constitute but one agreement.

22. **Entire Agreement.** This Agreement constitutes the entire agreement between the Parties with respect to purposes and services set forth in this Agreement. This Agreement supersedes all of their previous understandings and agreements, written and oral, with respect thereto. This Agreement may be amended only by written instrument executed by the Parties subsequent to the date hereof.

23. **Severability.** If any section, subsection, sentence, clause, or phrase of this Agreement is for any reason found to be unconstitutional or otherwise invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Agreement, so long as the ultimate purposes of this Agreement are not frustrated by such decision.

24. **Property Exchange.** Beyond monetary compensation, no property shall be exchanged between the Parties during the performance of this Agreement.

25. **Take-Home Vehicle.** CPFR shall provide a CPFR-owned vehicle to the SPFR Fire Chief for general business and limited personal use. Said use of the take-home vehicle shall be governed by CPFR policy on such vehicles.

26. **Attorney Review.** The Parties agree that this Agreement should be reviewed by their attorney. If the Parties hereto are represented by Eric T. Quinn, P.S., the agencies consent to the

dual representation by such firm, if any firm signatory is affixed hereto under “approved as to form.”

EXHIBIT A SCOPE OF SERVICES

CPFR shall provide Interim Fire Administration Services to SPFR as outlined below.

(A) General Executive Management and Administration Requirements

1. SPFR Fire Chief: CPFR agrees to make a CPFR fire chief available as needed to perform the duties of this Agreement, including attendance at SPFR's Commissioner meetings and other meetings as requested by the Board Chair.
2. The Board Chair, or designee, and SPFR Fire Chief shall meet at least monthly to review performance of the Agreement and, as needed, to re-evaluate the fee structure and hours of work.
3. CPFR and SPFR will continue to adhere to their own adopted level-of- service (LOS) standards, unless otherwise agreed upon in writing.
4. SPFR practices and procedures govern the manner by which the SPFR Fire Chief is to perform duties for SPFR, unless otherwise agreed upon in writing.

(B) SPFR Fire Chief Duties and Responsibilities

The SPFR Fire Chief shall administer the entities separately and consistent with the following understandings:

1. The SPFR Fire Chief will oversee and manage the administration and response operations of SPFR with the support of SPFR administrative personnel and with assistance from CPFR personnel if requested by SPFR.
2. SPFR will continue to provide administrative support resources to assist in conducting SPFR business, including, but not limited to, finance, human resources, facilities support, information technology, and legal.
3. The SPFR Fire Chief shall provide executive leadership and operational oversight in the following areas:
 - a. Planning, organizing, and directing the operations of SPFR.
 - b. Serving as the liaison between the Board Chair and SPFR employees.
 - c. Working collaboratively with the SPFR union and guiding and directing a staff of professional, technical, and administrative support personnel to deliver fire and EMS services to the SPFR community.
 - d. Maintaining a working environment conducive to positive morale, appropriate discipline and productivity, quality, initiative, and teamwork.

- e. Meeting with SPFR Commissioners as directed by the Board Chair, attending SPFR meetings and other public meetings, and preparing presentations to the Board of Commissioners. When the CPFR SPFR Fire Chief is unavailable, a designee may be assigned.
- f. Working on special projects, to include the following work items identified in the 2024 adopted Budget:
 - i. Assisting SPFR with the collective bargaining process.
 - ii. Providing recommendations to the Board of Fire Commissioners on operational and/or service delivery efficiencies as SPFR continues to work to address long-term fiscal challenges.
 - iii. Implementing a contract for services between SPFR and approved agencies.
- g. Representing SPFR (including CPFR) at regional meetings, such as Pierce County Chiefs and South-Sound 911 meetings.
- h. Other duties may be assigned by the Board Chair and agreed to by the CPFR Fire Chief.

(C) Additional Administrative Services

a) Training

- a. SPFR will participate in CPFR training
- b. To facilitate said training, SPFR will provide the following:
 - i. 1 FTE currently an Assistant Chief to assist CPFR in training needs and will be located at Station 60
 - ii. Training engine
 - SPFR will provide 1 training engine for use at Station 60
- c. SPFR foresees the hiring of 8 new recruits starting Fall of 2025
 - i. CPFR will assist SPFR staff for academy needs at Station 60
 - ii. Academy fees are included in the above fee for the ILA

b) HR services

- a. CPFR will provide the following HR services:
 - i. Assist in hiring 8 new firefighters
 - ii. Assist in any HR investigations for SPFR
 - 1. SPFR will assist with its current HR contract

c) Public Education

CPFR shall facilitate and assist in public education services within the jurisdictions of CPFR and SPFR in a manner that best serves all residents, business owners and property owners of both jurisdictions. CPFR shall maintain a calendar of Public Education events that provides notice to both Parties of planned events in both jurisdictions. CPFR shall assist SPFR in administering SPFR social-media accounts and messaging consistent with CPFR practice and procedure.

(d) **SPFR Secretary Services**

Effective July 1, 2025, and upon the appointed person taking the necessary oath of office and the filing of said oath (per RCW 52.14.080), CPFR shall provide District Secretary Services to SPFR. The appointed person, who shall remain an employee of CPFR, shall perform the duties of a District Secretary as contemplated under RCW 52.14.080 and other duties as assigned by the SPFR Board (as the district secretary is a Board-appointed position).

SUMMARY:

1. Pierce County Assessor-Treasurer is re-coding each parcel in GFR and OVFR districts to reflect PCFR tax coding where appropriate. To be completed prior to the end of the year, effective on 2026 taxes.
2. Provide legal with a list of OVFR and GFR apparatus (all licensed vehicles). Legal will prepare one Bill of Sale for each district, covering all vehicles. Will be prepared prior to year-end, cannot be switched until January 2026.
3. Provide legal with a list of OVFR and GFR properties. Legal will prepare Quit Claim deeds for each parcel. Will be prepared prior to year-end, cannot be filed until January 2026.
4. Liquidate all OVFR and GFR Keybank accounts to appropriate General Fund accounts and close accounts. Will be complete in January 2026.
5. Pierce County will transfer all funds held at the County, from OVFR and GFR to PCFR in January 2026. We are currently working with PC Finance to set a plan and coordinate the reports and timing. PC will not close year-end 2025 until March 2026, so the finalizing of this may not occur until PC closes 2025.
6. OVFR and GFR will still be required to file Annual Reports with the State Auditor's Office for 2025. These are due in May 2026.
7. OVFR and GFR will be audited by the State Auditor's Office for 2024 and 2025. The 2024 audits should occur in 2025, and the 2025 audits will occur in 2026.
8. Finalize shutting down OVFR and GFR social media accounts and webpages. This will be completed on 12/31/2025.
9. Report mergers to the IRS and that the Tax ID numbers for OVFR and GFR are no longer valid.

SUGGESTED MOTION:

“Move to approve the initial performance standards, with the two exceptions as recommended by staff, as needed for the continued development of the new organization’s Standard of Cover.”

SUMMARY:

With the merger of the three organizations on track to be completed by years end, the District has the need to establish a new Standard of Cover that represents the whole of the new organization.

The National Fire Protection Association has established industry standards (NFPA 1710) that are well researched and well documented whereby fire service providers can establish initial policy positions from. At the same time, NFPA 1710 allows for local considerations and conditions given the built environment.

Staff is recommending that the Joint Board utilize NFPA 1710 as the basis for development of the initial performance standards, with two exceptions, that will be used in the Standard of Cover. Current NFPA 1710 standards are:

- Alarm Answering: 15 seconds, 95% of the time
- Alarm Processing: 64 seconds, 95% of the time
- Turnout Time (Fire): 80 seconds, 90% of the time
- Turnout Time (EMS) 60 seconds, 90% of the time
- First Due Engine: 4 minutes (travel time), 90% of the time
- Second Due Engine: 6 minutes (travel time), 90% of the time
- Initial Full Alarm: 8 minutes (low/med hazards), 90% of the time
- Initial Full Alarm: 10 minutes, 10 seconds (high hazard), 90% of the time
- Single Family Effective Response Force: 17 Firefighters
- Multi-Family/Commercial Effective Response Force: 28 Firefighters
- High Rise/High Risk Effective Response Force: 43 Firefighters

Staff is recommending that two initial exceptions based upon local conditions and demonstrated performance over time:

Establish Alarm Handling, a product of Alarm Answering and Alarm Processing at 2 minutes, 90% of the time. As Alarm Handling is largely out of our control and is a function of South Sound 911, this is a much more realistic policy position to initially establish.

Establish a single Turnout Time at 1 minute 45 seconds, 90% of the time. Actual performance over time, from many fire service providers, demonstrates an inability to achieve the NFPA listed times for Turnout Time regardless of fire or EMS.

Once the Joint Board provides the initial policy position on performance standards, staff will provide current performance benchmarks against these standards, furthering the discussion and development of the Standard of Cover

SUMMARY:

1. May 2025 Financial Report
 - a. The Combined Fund Balance report reports all CPFR, GFR, and OVFR funds and reserves total as of the month end periods listed above.
 - b. Notable Items
 - i. Revenue - Operating Revenue are trending slightly over anticipated.
 - ii. Expenditures
 1. Overtime District wide is 10.6% over the annual budget, and \$6.4M in excess of May 31 targets.
 - a. The projected shortfall of overtime continues as projected at the budget workshop.
 - b. Chief is working with Ops and the Union to devise a plan that is sustainable.
 2. Operations overall are at 45.2% which is roughly 3.5% above anticipated.
 3. Fleet is again over target, increasing their shortfall from 6.1% to 12.1% over budget in May 2025.
 4. The mid-year amendment is anticipated to provide for these shortfalls, as projected in the May Forecast presented to the Board.
2. Myers Stauffer GEMT Audit for State Fiscal Year end 6/30/2023 is complete. There is one challenged item remaining outstanding, and I anticipate having the representation letter and final report to the Board by August.

SUMMARY:

The 4th of July holiday is traditionally one of the busiest operational periods for our fire district, and this year was no exception. We responded to 240 calls, including 103 fire-related calls. To proactively manage anticipated call volume and ensure continued service delivery, we implemented a coordinated operational enhancement plan developed by Chiefs Gibson & Kent. These measures were designed to maintain response readiness, support field crews, and minimize potential service disruptions across the district.

Supplemental Resources Deployed

- Incident Management Team Activation – An Incident Management Team (IMT) was stood up and based out of Station 60 during the high-volume evening hours. This team monitored district-wide activity, triaged lower-priority calls, and provided real-time support to field resources. Their presence allowed for more effective oversight and ensured that our frontline apparatus remained available for emergent, high-priority responses.
- Crew 6 Activation – Our wildland team, Crew 6, was staffed and in service. They provided targeted support on vegetation fires and extended operations, which allowed structural units to return to service more quickly.
- Brush 60 Deployment – Brush 60 was staffed and active during the peak activity hours, responding to minor fire calls and investigations. This additional resource proved valuable in offloading low-acuity incidents from our primary suppression units.

Call Volume and Performance

Call volume throughout the day was steady and consistent, as anticipated. Although the district handled a high number of incidents, we did not experience significant call stacking or overlapping critical emergencies. This allowed our crews to maintain effective and timely responses. Contributing to this efficiency were the newly implemented pre-alert response packages, which deploy a smaller initial response when incident details are unconfirmed. These streamlined deployments help preserve additional resources, ensuring their availability for subsequent calls entering the system.

Crew Performance

Our personnel demonstrated outstanding performance across the board. Crews worked diligently under warm and busy conditions, remaining professional, composed, and mission-focused throughout the day. Their ability to manage a high operational tempo without a lapse in service delivery was commendable.

Conclusion

The operational plan for the 4th of July was a success. We are proud of the work accomplished and grateful for the dedication shown by all involved personnel.

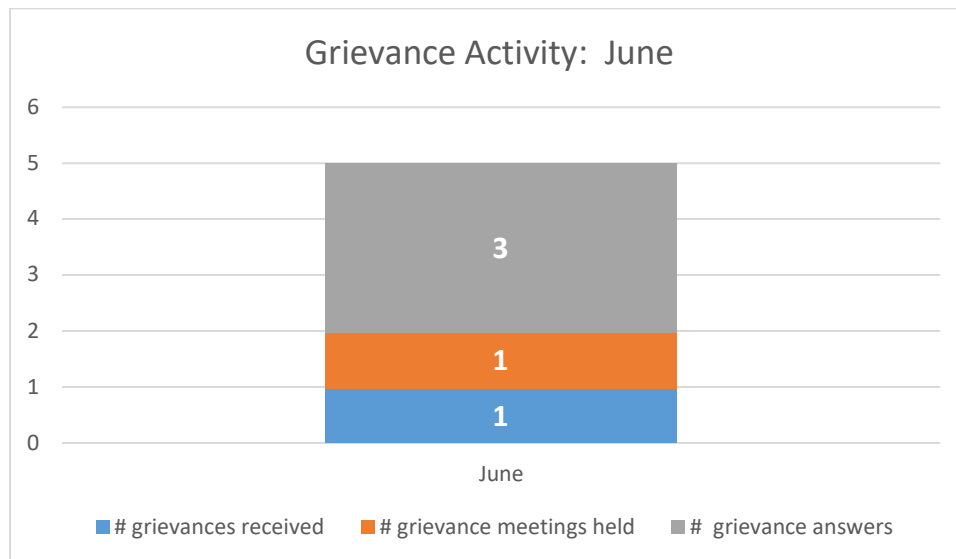

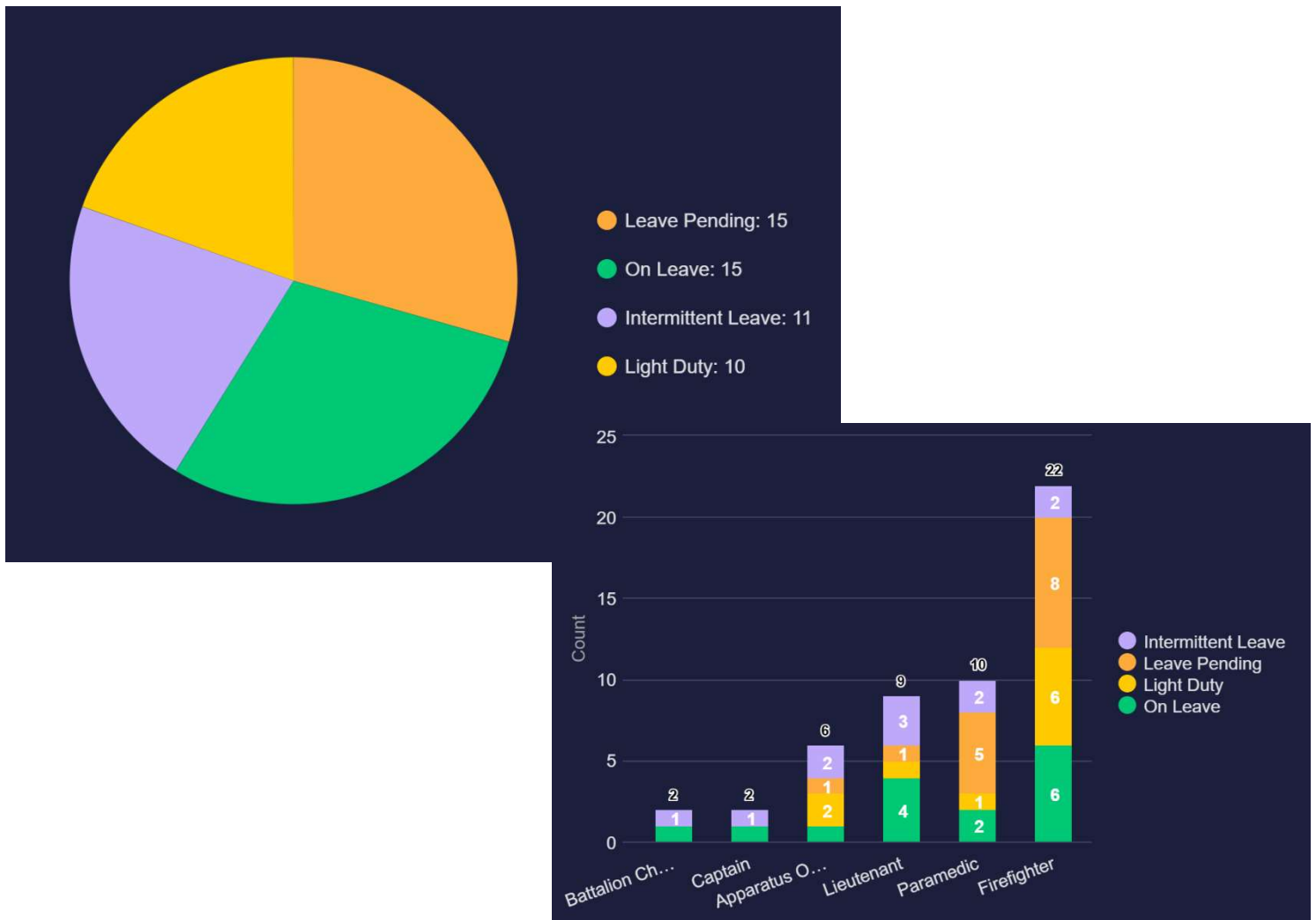

Station Updates

Station 66 is ready for use. Staff is working to prepare units for deployment out of the station. Two factors are weighing in on the deployment: GEMT cost recovery and the pending MOU process with Local 726. Staff believes we will have the station operational in August.

Work at Station 41 (Old Station 72) has been paused. Changes in direction for Engine 41 have occurred. As such, until staff understands the use of Engine 41, Station 41 renovations will be on hold.

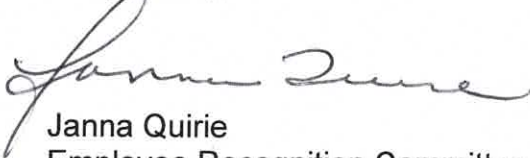

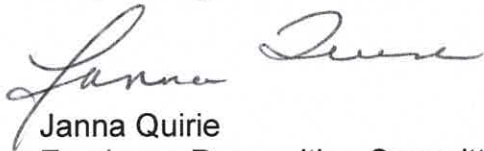
