## This is not a bill

The purpose of this letter is to notify you of your portion of the 2025 Fire Benefit Charge that will be collected with your 2025 Property Tax. You will find the Fire Benefit Charge listed under the "Special" category on your property tax statement.

Dear Orting Valley Property Owner:

The Fire Benefit Charge (FBC) is an alternative method of securing operation funds for the provision of fire and emergency medical services. The FBC was approved by District voters in 2021 by over a 65% margin. The FBC replaced the Maintenance & Operations levy as well as \$0.50 per thousand of the fire levy. The FBC allowed the district to add much needed staff for additional response units. Under State Law the FBC may be applied by the Fire Commissioners to cover up to 60% of the annual operation budget of the district. In 2025 the FBC will cover 37% of the budget. The FBC must be approved by District voters every 6 years.

The Board of Fire Commissioners for Orting Valley Fire and Rescue unanimously approved no change to the 2025 FBC from 2024. What does this mean? It means you will pay the same amount for your FBC in 2025 as you did in 2024. In addition to keeping the FBC the same in 2025, we are also excited about our ability to participate in the regional collaboration that is occurring between Orting Valley Fire & Rescue, Central Pierce Fire & Rescue, and Graham Fire & Rescue. This collaboration is driving out duplication, creating efficiencies, and improving service to you, while allowing us to keep costs as low as possible.

The FBC is combined with a flat fire tax rate not to exceed \$1 per thousand (was \$1.50 per thousand) and the \$0.50 EMS levy to fund fire and EMS services. Unlike property taxes, the FBC is based on total square footage of buildings, garages, barns, stables, etc. on the property as well as the intended use of the property. Consequently, the owner of a commercial building of like square footage would pay more than a residential homeowner.

All of us at Orting Valley Fire and Rescue understand the impact inflation is having on our community, and we are proud that we can provide better service without having to raise the FBC. We will continue to strive to be good stewards of your tax dollars. We will work diligently to focus on exceeding our citizens expectations and providing exceptional service while being mindful of managing costs and remaining within our approved budget. We appreciate your support and will continue to serve you with kindness and professionalism.
